## ABOUT ARMENIA

Armenia welcomes foreign investment with a relatively open investment and trade policy. Foreign companies are entitled by law to the same treatment as Armenian companies (national treatment).

Armenia has strong human capital and a well-educated population, particularly in the Science, Technology, Engineering and Math (STEM) field. The high-tech and information technology sector has attracted significant foreign investment to Armenia. Many international companies have established branches or subsidiaries in Armenia to take advantage of the country's pool of qualified specialists. (*Development Foundation of Armenia, 7/12/16.*)

## AMULSAR CONSTRUCTION UPDATE

Construction activities at Lydian's 100%-owned Amulsar Gold Project continued to proceed as planned during May. Advancing site earthworks continued to be the priority with the completion of the construction warehouse platform and continued progress on the ADR platform and heap leach facility (HLF) temporary sediment dam. Construction activities have **commenced at higher elevations and the tender process is well underway with awards complete for the pre-engineered buildings, earthworks for the HLF and crushing and screening area, and the freight management contract.** Construction of the 680-bed residence camp continues and occupancy is expected to begin late June or early July 2017.

Initial deliveries of primary mining equipment will commence in late summer. The mining fleet for Amulsar will include **19 Caterpillar 789D 180-tonne capacity haul trucks, one Caterpillar 994 front-end-loader and two Caterpillar 6040 hydraulic shovels.** A training simulator has been purchased to train equipment operators.

The Amulsar Gold Project is **advancing its application to secure Pre-Operational Certification** under the International Cyanide Management Code with positive assessments by an International Cyanide Management Institute (ICMI) listed third party auditor and a commendation by the ICMI on Lydian's commitment to the Cyanide Code and its pursuit of Pre-Operational Certification.

Components of the Caterpillar 789D haul truck are manufactured at Caterpillar facilities in Illinois, Indiana, and Mexico. The body of the truck will arrive in several large pieces and be welded at site. Other components (axles, cab, tires, etc.) will be added during the assembly process, also at site. Nine of the trucks are expected to be delivered during 2017; three in August, September, and October.
